

OBEDIENCE & RALLY TRIAL ENTRIES

Completion of Entry Forms

Club Secretaries would appreciate if competitors would follow these guidelines when completing trial entry forms for obedience & rally trials.

Please do not use any staples anywhere for any reason when completing your entries. It is time consuming and somewhat exasperating for Secretaries to remove staples on each entry when opening envelopes for receipting and sorting.

Ensure all writing is legible and dog's details recorded exactly as listed on the latest Pedigree Certificate or Associate Certificate of Registration. Please do not include superseded titles - only include the latest title granted for each discipline.

All entry forms are to be standard size being 81 mm X 26.7 mm (3.5" x 10.5"). Please do not send untrimmed A4 sheets. All entries to include an original signature and one entry form per class per dog.

- (1) Name of the Affiliate Club hosting the trial and date of trial.
- (2) Breed
- (3) Name of Dog including all titles gained as per the Pedigree or Associate Certificate.
- (4) Registration number as per the Pedigree or Associate Certificate
- (5) Owner/s Dogs SA membership number
- (6) Class entered
- (7) Height of dog at Withers – only for classes where jumps are required
- (8) Registered owner/s of the dog as per Pedigree or Associate Certificate
- (9) Entry Fee including catalogue fee if required

Optional (10) If you are a financial member of an Affiliated Club you may include the Club abbreviation/s on your entry for inclusion in the catalogue. Some Clubs require members to include the Club represented in the catalogue for calculation of Club End of Year awards or for Teams events.

Details of Bred By, Sire and Dam are not required for all breeds Obedience or Rally Trials. Include these details only for Restricted or Breed National Trials.

Your assistance in ensuring all of the above will greatly assist Trial Secretaries.
